ADOPTED ATTORNEY GENERAL'S MODEL RULES BY REFERENCE.

RULE SUMMARY: The amended rule amends the prevailing rates of wage as determined by the Commissioner of the Bureau of Labor and Industries for the period beginning July 5, 2024. This is not the adoption of a Model Rule, but rather is a permanent rule under the authority of ORS 183.335(10), which excludes rules under ORS 279C.815 from certain provisions of law, including notice requirements that otherwise would apply.

Prevailing Wage Rate Determination/Amendments to Determination. ¶¶

(1) Pursuant to ORS 279C.815, the Commissioner of the Bureau of Labor and Industries has determined that for the period beginning July 5, 2024, the prevailing rates of wage for workers upon public works in each trade or occupation in the locality where work is performed are the wage rates stated in the publication of the Oregon Bureau of Labor and Industries entitled Prevailing Wage Rates for Public Works Contracts dated July 5, 2024, are the prevailing rates of wage for workers upon public works in each trade or occupation in the locality where work is performed for the period beginning July subject to any amendments to those rates that are contained in the applicable special wage determination and rates amendments: Amendments to Oregon Determination 2024-02 (dated October 5, 2024). ¶¶
