ADOPTING OR AMENDING EITHER (1) ATTORNEY GENERAL'S MODEL RULES BY REFERENCE; OR (2) RULES RELATING TO PUBLIC CONTRACTS AND PURCHASING PURSUANT TO ORS 183.335(10).

RULE SUMMARY: The amended rule amends the prevailing rates of wage as determined by the Commissioner of the Bureau of Labor and Industries for the period beginning July 5, 2025. This is an amendment to rules relating to public contracts and purchasing pursuant to ORS 183.335(10), which excludes rules under ORS 279C.815 from notice requirements.

Prevailing Wage Rate Determination/Amendments to Determination. ¶¶

(1) Pursuant to ORS 279C.815, the Commissioner of the Bureau of Labor and Industries has determined that for the period beginning ~~January~~ July 5, 2025, the prevailing rates of wage for workers upon public works in each trade or occupation in the locality where work is performed are the wage rates stated in the publication of the Oregon Bureau of Labor and Industries entitled Prevailing Wage Rates for Public Works Contracts dated ~~January 5, 2025~~, subject to any amendments to those rates that are contained in the applicable special wage determination and rates amendments: ~~Amendments to Oregon Determination 2025-01 (dated April~~ July 5, 2025). ¶¶
