## RFP 5401 – Transition Network Facilitator

## **Questions and Answers**

May 13, 2014

- Q. 1. Section 7 General Terms and Conditions (4) Key Contractor Personnel: Is the RFP for a Professional Services Contract with the applying agency or the person the agency hires to perform the work of the RFP?
- A. 1. The Contracts resulting from this RFP will be with the applying agency.
- Q. 2. Section 7 General Terms and Conditions (5) Independent Contractor: Responsibility for Taxes and Withholding: Is the applying agency considered the independent contractor employing the person performing the work of the RFP?
- A. 2. Yes.
- Q. 3. Exhibit A Scope of Work Page 23 Purpose: Is the total hours for the Transition Network Facilitator to start July 1 and work during the summer or an LEA school calendar?
- A. 3. The Facilitator will work year round, not on a LEA school calendar.
- Q. 4. Exhibit A Scope of Work Page 23 Purpose: Successful proposers are to hire a person as Transition Network Facilitator:
- A. 4. Yes. The resulting Contracts are with school districts and ESDs who will then recruit a Transition Network Facilitator.
- Q. 5. Exhibit A Scope of Work Page 23 Purpose: Can the successful proposer, assign assignment to a current employee who meets the qualifications?
- A. 5. That may be part of your proposal, but please note the following statement found on page 23 of the RFP:

"\*\*Note\*\* The successful proposer must include at least one representative from the ODE Transition Team on the hiring committee for the Transition Network Facilitator."

- Q. 6. Exhibit A Scope of Work Page 24 Deliverables and Payment Schedule: Where is a list of the Tentative activities the Transition Network Facilitator is to accomplish?
- A. 6. The successful proposer will recruit a Transition Network Facilitator. Proposers are asked to give a tentative list of the proposed activities to accomplish that goal.

- Q. 7. Is this a 1 year grant or a biennium?
- A. 7. Per Section 1.3 contracts are anticipated to end June 30, 2015.
- Q. 8. If it is a biennium, is the 1126 hours over one year or two?
- A. 8. If contracts were executed by June 1, that would be 13 months.
- Q. 9. DELIVERABLE AND PAYMENT SCHEDULE Could we get an example of what expected milestones might be and an idea of how they are expected to be completed?
- A. 9. An example is not available. The deliverables are the activities a proposer would take to recruit and hire a Transition Network Facilitator.
- Q. 10. ATTACHMENT C CERTIFICATION OF COSTS references a different RFP in the first paragraph. Is that an error?
- A. 10. Yes, that is an error. Agency will accept that form, or proposer may use the attached, revised ATTACHMENT C.
