# Oregon Department of Human Services Self-Sufficiency Program Information

## Supplemental Nutrition Assistance Program (SNAP) provides monthly food benefits to help purchase healthy food.

- This program helps people pay for groceries, learn about nutrition, and get job training and support. SNAP helps families stretch their food budget but may not meet all their food needs.

### Temporary Assistance for Needy Families (TANF) provides a monthly cash benefit to families with children who meet income limits.

- This program provides cash that families can use to pay for things they need
  while they work toward supporting themselves. The amount of money a family
  gets depends on how much money they make and how many people are in the
  family.
- The Job Opportunity and Basic Skills Program (JOBS) helps with employment and training, family stability and family well-being.

#### **Refugee Services**

- Refugees and others with an eligible immigration status can get help with cash, medical, employment and other services when they first come to Oregon. Oregon gets funding to provide these services from the federal Office of Refugee Resettlement and State Legislature. Local resettlement agencies help refugees get connected to services.

#### **Domestic Violence Survivor Programs**

- Temporary Assistance for Domestic Violence Survivors (TA-DVS): This program helps families and pregnant individuals experiencing domestic violence with temporary cash assistance so they can leave and stay safe from abuse. Eligible individuals will receive up to \$1200 to support with moving or relocation costs and items to stay safe. Call a local office to talk about the safest way to apply.
- Co-located DV Advocates Program: Provides a collaborative partnership between 31 agencies that support all 36 counties across Oregon to provide confidential domestic violence advocacy in SSP and Child Welfare offices.
- Survivor Investment Partnership (SIP): A partnership with the nine Tribes of Oregon, eight culturally specific providers and 31 co-located advocacy agencies to provide services to survivors of domestic violence and sexual assault.
