OHA Medicaid Waiver Evaluation Sessions

Background: Oregon is required to do an independent evaluation of its Medicaid Waiver. The Oregon Health Authority (OHA) has contracted with CORE — the Center for Outcomes Research and Education — to develop the evaluation design for the current Medicaid Waiver. The federal government has a list of evaluation requirements, and OHA wants to be sure that the priorities of community partners are also represented in the final evaluation plan.

Invitation for feedback: CORE will be hosting two virtual waiver evaluation feedback sessions for CCO community advisory council members and we'd love to have you join! We'll start with a brief reminder of what's new in this waiver, as well as some background on the evaluation planning process and federal requirements. Then we'll ask what questions or topics YOU think are most important to include when evaluating how the waiver is going and what impact it is having.

Palliative Care Training for CHWs – Register Now

Oregon State University, College of Public Health is offering a continuing education source for community health workers (CHWs) in palliative care. The course begins Jan. 12 and will be co-facilitated between Erin Collins, MNE, RN, CHPN, co-founder and program director, Peaceful Presence Project, and Oralia Mendez, MPH, CHW, director of the CHW Program at OSU.

This online course provides a continuing education/professional development opportunity for CHWs who have completed entry-level CHW training. It addresses care of the individual and family living with serious illness or nearing the end of life. This course will introduce the end-of-life doula model of care and core principles/domains of palliative care and explore various skills CHWs can incorporate into their work.

This course is open to anyone trained as a traditional health worker (CHW, PHN, PSS, Doula, PWS) and is part of a Cambia Health Foundation Sojourns Scholar project with a goal of increasing access to palliative care in rural Oregon. Residents of Jefferson, Crook, Grant, Wheeler and Harney counties are especially encouraged to apply, and scholarships are available.
