### Why upgrade:

# Insulation

# **Ductless Heat Pump**

DHPs are 2-3x more efficient than electric resistance furnaces, baseboard & ceiling heat, and wall heaters. Plus, they are easy to install and provide heating and air conditioning.

- √ \$800 rebate OR \$4,500 0% loan if converting from zonal electric heating
- √ \$900 rebate OR \$4,700 0% loan if converting from electric forced air furnace

# **Ducted Heat Pump**

# Why upgrade:

Ducted Heat Pumps can deliver 3x the energy they consume.

- √ 0% Loan up to \$7,200 OR
- ✓ Up to \$1,400 rebate for customers with electric forced air furnaces upgrading to a qualifying heat pump
