## **RULE SUMMARY**

The proposed rules would be codified in Division 041, under Oregon Administrative Rules (OAR) Chapter 660 and would direct review under Senate Bill (SB) 1049 and Measure 49 (M49) of about 400 otherwise ineligible Measure 37 (M37) claims; and would also include measures for local implementation of M49 authorizations. This rulemaking would make permanent some of the temporary M49 rules adopted by the Land Conservation and Development Commission in April of 2010 to implement SB 1049, which enables certain categories of landowners with otherwise ineligible M37 claims to make M49 elections. The bill requires affected claimants to pay a \$2,500 fee to cover the costs of further processing their claims and that DLCD process those claims by June 30, 2011. This rulemaking would also involve adoption of a new rule to assist local governments in working with landowners to implement their Measure 49 authorizations under Section 11 of M49.

The Agency requests public comment on whether other options should be considered for achieving the rule's substantive goals while reducing the negative economic impact of the rule on business.
