RULE SUMMARY

The proposed new rules and rule amendments will implement the population forecasting program required by ORS 195.033 and 195.036, in coordination with the Portland State University Population Research Center. The proposed rules will regulate the transition to new population forecasts issued by the center and by Metro, from population forecasts produced under previous statutes, former ORS 195.034 and 195.036, as those section were in effect before the effective date of ORS 195.033 and 195.036.
