## **TRAINING ANNOUNCEMENT and REGISTRATION FORM**

### **“Boot Camp IV”**

The **OREGON DEPARTMENT OF JUSTICE’s DOMESTIC VIOLENCE RESOURCE PROSECUTOR program** is offering a fantastic DV conference for **PROSECUTORS**. This conference will focus on developing and honing trial advocacy skills through lecture, group discussion, and intense participation by attendees. The training will also focus on best practices in other areas of DV prosecution, such as collaboration with victims’ rights attorneys, working with child witnesses, and utilizing DV experts for case consultation and/or trial.

- Who Should Attend: Oregon and Tribal Prosecutors who handle DV cases. The training is appropriate for **ALL** levels of prosecution experience
- When: **October 28-30, 2013**
- Where: The Elizabeth Street Inn, Newport, Oregon
- Faculty/Presenters: Veteran DV prosecutors and victim resource providers from around Oregon
- COST: REGISTRATION IS FREE. Attendees will be responsible for covering expenses (excluding lodging which will be paid by DOJ) up-front.
- *(Attendees will be provided continental breakfast. ALL attendees will be reimbursed for lunch (at the federal/state per diem rate). Attendees living more than 50 miles from the conference site will be reimbursed for dinner (at the federal/state per diem rate). ALL attendees will be reimbursed for mileage with proof of mileage driven (at the federal/state rate of .50/mile)).*

There are **20 seats available** at this conference. In an effort to facilitate attendance by as many counties and tribal nations as possible, the application process will only accept the first **TWO** applications from any one jurisdiction. If there are additional seats available after the initial application process has been completed, additional attendees from already attending jurisdictions may be admitted. A waiting list will be maintained for those jurisdictions wishing to send more than two attendees. Priority *may* be also be given to those prosecutors attending “Boot Camp” for the first time.

CLE credit will be requested from the Oregon State Bar for this conference.
