

**Addendum to Conditional Release Agreement or Security Release Agreement or
Order in Case No. _____**

IT IS FURTHER ORDERED that:

Defendant shall not harass, stalk, or threaten the victim or engage in other conduct that would place the victim in reasonable fear of bodily injury.

Defendant shall not use, attempt to use, or threaten to use physical force against the victim that would reasonably be expected to cause bodily injury.

☐ **FEDERAL FIREARMS FINDINGS (BRADY):** This Order may subject defendant to federal prosecution for possession, receipt, shipping, transportation, or purchase of firearms or ammunition while it is in effect. [OJIN Event Code: **ORBY**; LEDS Brady Code: **Y**]

The Court finds:

A. Relationship: The victim is (*check at least one*):

- ☐ A spouse or former spouse of defendant.
- ☐ The parent of defendant's child.
- ☐ A person who does or did cohabit (live in a sexually intimate relationship) with defendant.
- ☐ Defendant's child.
- ☐ A child of an intimate partner* of defendant (*intimate partner is spouse/former spouse, cohabitant/former cohabitant, or parent of defendant's child).

B. Notice and Opportunity to Participate:

- ☐ The Order was issued after a hearing of which defendant received actual notice and at which defendant had the opportunity to participate.

C. Terms of Order:

- ☐ The Order restrains defendant from harassing, stalking or threatening the victim or engaging in other conduct that would place the victim in reasonable fear of bodily injury to the victim; **AND**
- ☐ This Order by its terms explicitly prohibits the use, attempted use, or threatened use of physical force against the victim that would be reasonably expected to cause bodily injury.

FIREARMS NOTICE under 42 USC §3796gg-(4)(e): As a result of this Order, it **may** be unlawful for defendant to possess, receive, ship, transport or purchase a **firearm or**

ammunition pursuant to **federal law** under 18 USC §922 (g)(8). This Order also **may** negatively affect defendant's ability to serve in the Armed Forces of the United States or to be employed in law enforcement. [OJIN Event Code: **NOGR**]

If defendant has questions about whether federal or state laws make it illegal to possess or purchase a firearm, and/or about whether this Order will affect defendant's ability to serve in the military or be employed in law enforcement, defendant should consult an attorney.
