Professor Garvin and Erin Greenawald, DOJ's DV Resource Prosecutor, will provide participants with a concise overview of victims' rights, as well as discuss the significant impact a 'victim-blaming' culture has on a victim's ability to engage (or not) with the criminal and civil justice systems. The training will highlight the long-lasting effects on victims of trauma, and provide participants with numerous tips and techniques on how to more effectively and empathically engage with victims in a trauma-informed manner which can significantly and positively contribute to the success of the investigation and prosecution of domestic and sexual violence cases.

Ms. Bayliff will provide participants fascinating research and insight on how our use of language shapes our response to gendered violence. This interactive session will explore the language of sexual assault: how we talk about and write about this crime. We will discuss specific examples of the language we use and

explore how to discuss sexual assault in a way that more accurately depicts the crime. Ms. Bayliff is a nationally recognized expert on issues regarding sexual assault and violence against women. She has worked with a wide variety of people in the US, Canada and Europe. She has been an attorney for almost 30 years and has helped develop sexual assault prevention policies including comprehensive nationwide plans and materials for educating judges, court personnel and military about sexual assault.
