



# LO278: NFIP/ COMMUNITY RATING SYSTEM

May 4 - 7, 2020



The City of Eugene Public Works Engineering Division is pleased to co-sponsor, with FEMA, a 4-day training on the Community Rating System (CRS), a nationwide initiative of FEMA's National Flood Insurance Program (NFIP). This course is normally conducted at the Emergency Management Institute in Emmitsburg, MD, and The City of Eugene is honored to be chosen to hold a field deployed version of this class.

## Course Description

This course covers the Community Rating System, such as, what is eligible for credit under the CRS, how a community applies and how a community modifies an application to improve its classification.

## Course Objectives

- Describe how to join the CRS program and improve your community CRS classification
- Identify ways to earn CRS points by reducing and avoiding flood damage to insurable properties
- Describe how to gain CRS points by fostering comprehensive floodplain management
- Understand how to take advantage of available CRS points as you improve the insurance aspects of the NFIP

## Target Audience

Municipal and Tribal Officials, Planning Officials, State Officials, FEMA staff, CRS Coordinators, emerging CRS communities and others learning about CRS in order to provide technical assistance to communities seeking to apply for CRS credit.
