

What is Senate Bill 1585

- **Supports the creation of a Restaurant Meal Program (RMP) Task Force**
 - The RMP Task Force shall analyze all options under the Food and Nutrition Service (FNS) guidance that maximizes food choices for participants;
 - The RMP Task Force will develop a plan for implementation of the program which
 - Examines access to the program;
 - Monitors efficacy of the program;
 - Tracks cost of the program;
 - Plans program implementation
 - The RMP Task Force will deliver a recommendation report to legislature by 1/31/2025

What is the Restaurant Meal Program (RMP)

- Allows RMP eligible SNAP participants the ability to purchase meals at a restaurant or prepared food at a grocery store with their SNAP benefits.
- To participate in the program individuals must be eligible for SNAP and meet one of the following:
 - Elderly (60 years of age or older);
 - Disabled (receiving disability or blindness payment or receives disability retirement benefits from the government agency due to disability being considered permanent)
 - Houseless; or
 - A spouse of a SNAP participant who is eligible for the RMP

What is the Restaurant Meal Program (RMP)

Which restaurants can participate in the RMP?

- Must be in a state that operates a RMP;
- Receive approval from the State Agency (ODHS);
- Provide a signed agreement to FNS retailer division and;
- Be authorized by FNS to accept SNAP benefits

State options

Each state can set the requirements for choosing how many and which restaurants can participate in the restaurant meal program:

- RMP Taskforce will determine RMP geographic pilot site and;
- Restaurant selection criteria


What is the Restaurant Meal Program (RMP)

States that currently participate in the RMP




