GIS Collaboration during State of Emergency Events	Two recently simulated emergency incidents in Oregon highlighted significant problems related to geospatial support. Group discussion disclosed that each agency responds independently to incidents and that there may be considerable duplicative effort. Other than for Wildfires as supported by ODF no other agencies present had plans in place for geospatial support. Several questions came up about primary agency contacts for geospatial data during emergencies. The consensus was to utilize the contact lists as published by the DAS/GEO http://gis.oregon.gov/DAS/EISPD/GEO/coordination/contacts.shtml Other discussion about mutual aid and relationship to federal response illustrated that this is a significant issue with not enough information currently being available. The GPL Chairman created a sub-committee to be led by Terri Noble at OMD, to review the issues and report back to GPL at a later date.	Creation of sub-committee to review issues.
