GIS Cadastral FIT agreement:

Update: Phil McClellan - Sent out draft version of 2015 Cadastral GIS data License agreement to DAS GEO. This is the agreement that the State worked out with sharing of Cadastral data from Counties. Couple big changes:

- Old agreement with counties for \$1000.00 funding/reimbursement is no longer viable.
- Will allow state agencies to display ownership lines and ownership some info via web service.

Since this was originally an agreement that came out of ORMAP and GPL, we wanted to bring this to GPL to see if there are any comments or concerns, before we move forward or propose anything further changes to the counties. Please provide feedback/comment to Phil McClellan by Sept 1, 2015

Could see this eventually set up so that each county could provide their respective taxlot/ownership information as web services that each agency would then consume. This way each county has complete control over their datasets. What is the next step? Need to have everyone agree to this and on the same page with one agreement in place. Hoping to replace the existing agreement with this one so there is no need, for each county to sign another contract.

GeoScience FIT – Lina Mia from DOGAMI took over as the FIT lead and is planning on pulling the effort together here soon.

ESRI Conference

Update: CY Smith attended the Senior Summit on Sunday. Came away with the impression that the conference had a few main points:

- 1.) Chris Cappelli discussed the idea of Authoritative Datasets and how important AD is for Government Decision making. Will be the main point of focus for ESRI in the coming year.
- 2.) ESRI will to offer concurrent licensing for ArcGIS Pro at 10.4. Also talked about more Metadata support for AGOL.

Spoke with a number of Imagery vendors at the ESRI conference. Looking into Imagery as a service provided from Google and possible Hexagon. Cost to the State of Oregon (local government agencies can stream data) could possibly be in the neighborhood of \$1,200,000.00 for perpetual right for six inch imagery. Google plans on flying rural area every three years and urban areas every year. This does not include IR datasets and is instead a mix of Leaf on/Leaf off.

Misc.:

- Will begin working again on the old draft document for the Data Sharing Legislation from previous years.
- Shared Services – Still on hold with the physical move, due to the DAS directors concerns. GEO will eventually physically move over to DLCD, but organizationally (funding wise) GEO will still be part of the CIO office.
- CY is now part of the DLCD management team and is currently looking at performance measures, but will follow a different approach to what was done in the past with the *Ten year Plan* over at DAS.
- The EC that was redrafted is currently making its way through a review process. The OGIC chair would be selected by the council and change over time.

Framework

Update: Bob. Denouden OGIC acted on Funding proposals (move forward on 7). Have sent out to appropriate agencies for their approval. OGIC Deferred on Lidar DATA; EFIT working on modifying the proposal.

Historical Rail – working on a modifying that proposal to get back to OGIC to move forward.

Had a planning -work group meeting. Robert Manzaleo has taken over leadership from Gail Ewart. Will pivot to a statewide zoning layer/comp layer.

Imagery FIT met last Month – Ian Reed will acquire the 2014 (1 meter, 4 band) NAIP from NRCS Forth Worth office via portal drives.

FIT lead met last month to kick off the Framework Data Elements Prioritization process.

ODOT Phil Smith leads a work group on Active Rail Data Standard in the next couple of weeks.

Next Framework Forum will be In December 14, 2015 at Metro in Portland. Social activities will follow.

DOGAMI is coordinating a Lidar Bathymetry project along the Willamette River, and looking for partners to help funding. Will send out notification to GPL ASAP.

Agency Round table

- DSL: R. Sounhein.
 - Completed our building remodel and divisions reorganizing.
 - DSL is working with DEQ on the Placer Mining project (Senate Bill 838). There will be a Moratorium on Placer Mining on Oregon Rivers (effective on Jan 2016).
 - Creating a Data Portal with ESRI's OpenData for DSL authoritative data.
- ODOT: Casey Ragin – Hosting ArcGIS Server admin class at \$1000, per seat. Completed Migration from ODATO AGOL Organization and now part of State of Oregon's AGOL. No more AGOL "Sub groups" with DAS.
- ODA: Diana Walker – Were now on our new GIS system and still having a few issues, but hope to have everything with ArcGIS Server set up and working correctly here soon. ODA did hire an intern from Portland State for a three month temporary position to facilitate a water quantity analysis in the Willamette basing.
- OWRD: Bob Harmon – The agency has been tasked by the Governor to work with other state agencies to reduce their overall water use. Wrapping of the conflation work of stream codes to NHD.
- ODF: Emmor Nile – Completed a revision of older Public Ownership layer. There were issues related to public ownership layer; not all "Fee Title holder" owners are actual managers of the land. Therefore the new layer reflects a redesign from land ownership to land management. Seven different GIS staff supporting fires incidents across the state.
- OWEB: Troy Wirth – Still working with integrating the Fish Passage tool with Barrier dataset from ODFW. Did a survey of Watershed council and SDCD on their needs for GIS. Out of the 60 groups surveyed 41 stated that they would like ArcGIS/AGOL. Not all groups can be eligible for nonprofit support/funds status. Agency is also involved in an office remodel
- OEM: D Stoelb – working on monitoring fires out there. Have included new datasets into RAPTOR from NWCC related to fires. Also having an in-site GIS conference (with 911 folks) towards the end of August. Just pushed out a new Web App that details information about search and rescue data.
- DLCD: Tanya Haddad – Most of the DLCD users are now using the new system and datasets from the integration with ODA. Been spending more time with. Inside of DLCD staff has been requesting a new layer for the boundaries of incorporated communities across the state. Might look at the Night Time lights to add to the list as suggested via Emmor Nile. If anyone has any ideas please forward to DLCD.
