February 2021 Severe Winter Weather Ops Center 2021-0453 Executive Order 21-02 Status as of February 18, 2021

NWS

- Widespread rain on west side of the state
- Most snowfall in central and southern cascades for next 2 days
- Temps to warm through weekend, 50s in west side, lows in 40s
- East side temps cooler, slight chance for freezing rain in Pendleton
- Temps to dip down next week, but should continue to be rain
- Several different systems to pass over OR

ESF-1: Transportation - ODOT

ESF-2 – Communications – DAS: William Chapman

- ATT: 21 towers out of service, 73 still on generator power
- Verizon: 8 towers out of service, 24 sites on generator, 5 on battery power
- TMobile: 18 sites out of service, reporting 99% customer coverage
- Wave Broadband has restored connectivity to Molalla, still damages to link between Willamina and Sheridan
- Lumen (formerly CenturyLink): 500 voice customers out of service.
- Comcast: 44,000 outages as of this morning
- Ziply: Fully restored from storms but had vandalism to fiber line in Scotts Mills area. Reported to LE and Fusion Center.
- All PSAPs back on commercial power
- State Radio Network down to 4 sites on generator, but all restored and functional
- State Data Network: Still have 8 sites down (from 18)
- Provided temporary comms support to Salem Fairgrounds (since restored) and Wilsonville Warehouse.

ESF-2: Communication – OPUC: Lisa Gorsuch

- Comcast Comms would like to coordinate and work with PGE as restoration efforts occur to get into the same areas for restoration
- As of 1300 down to 98,036 outages across the state (see below)
- Pacific Power: 95% of power restored
- PGE: Should have 90% restored by Friday 2/19
- Counties: Especially Clackamas and Marion: Please review status of outages, how can PGE further assist in welfare checks, etc.
- Thank you to BIZ-OR and OEM P3 for support to line crews for facilitating finding food and lodging
