8. Incident Summary:

Twenty eight active fires currently are burning in Oregon, with an estimated total of 195,909 acres burned. The National Weather Service issued a Red Flag Warning for wind and low relative humidity from 11 a.m. Friday to 11 p.m. PDT Saturday.

Affected areas in Oregon: Fire Weather Zone 602 North Oregon Coast Range, Fire Weather Zone 603 East Slopes of the Central Oregon Coast Range and Fire Weather Zone 604 Willamette Valley.

Winds: Northeast 10 to 20 mph with gusts up to 30 mph. East wind of 15 to 25 mph with gusts to 40 mph can be expected near the west end of the Columbia River Gorge and Oregon Coast Range ridges. Relative humidity may be as low as 15%.

Impacts: Conditions may be favorable for rapid fire spread that may threaten life and property. A combination of the above conditions can contribute to extreme fire behavior.

Due to the forecasted weather, Portland General Electric, Pacific Power, Consumer Power Inc., Lane Electric, and Eugene Water and Electric Board are anticipating executing public safety power shutoffs (PSPS) for approximately 59,000 customers (electrical meters) within Benton, Clackamas, Douglas, Hood River, Lane, Lincoln, Linn, Marion, Polk, Multnomah, Tillamook, Washington and Yamhill Counties. PSPS were initiated September 9 and as of 1400, there are 32,234 customers without power due to PSPS preventative outages and other causes.

Douglas County

- Coordinating with Pacific Power and Douglas Electrical Co-Op. Currently Douglas Electric is not planning any PSPSs.
- We were advised by Pacific Power at 1200 hours that they indent to shut off power to all identified PSPS areas in Douglas County at 1300 hours.
- Duration is anticipated for the event to drop off Saturday morning.
- Once power is shut off, it is hoped to start restorations Saturday morning.
- Depending on conditions, this may take all day Saturday or longer.
- Community Resource Center will be operational 8AM Friday Glide HS Cafeteria
 - Hours of operation 8AM to 10PM Friday and Saturday.
- Douglas Public Health Network is working with ODHS on pre-identifying individuals that have special needs or are power dependent. Red Cross will not provide shelter services for this event.
- Issue of individuals that require assistance. Working with private nonprofits and ODHS.

Hood River County

Nothing to report.

Lane County

- Moving into conflagration for the Cedar Creek Fire.
- Oakridge now in level 2 evacuations.
 - Lane County SAR doing walks to house to let them know and see if there are any needs.
- Using mutual aid SAR.
- ODOT is closing Highway 58 from the pass to Oakridge signs 58 east bound at Parkway Road and again at Lowell. 58 west bound at Crescent Cutoff and Willamette Pass.
 - OSP with ODOT assisting at those closures.
- EWEB is doing PSPS in the McKenzie Highway area tonight.
- Fielding calls for those needing medical supplies so directing to 211 and their medical providers.

- Charter Spectrum customers won't have internet once PSPS established (no messages currently on sharing with folks who won't have internet/Wi-Fi).
 - Going to need state support.
- No JIC or PIO call center yet. Dispatch centers managing calls and not exceeding capacity.
- Lane Community College for temporary evacuation point (TEP).
- Data analytics coming onboard to start gathering information to work with Lane Transit to look at supporting evacuation.
- Shelter at Lane Events Center at Wheeler Pavilion with Red Cross and ODHS.
- Utilities are experiencing outages due to wind impacts on lines.
 - Still planning on more PSPS today at 1700.
- Website is up and running with info (been some challenges with that today) lanecountyor.gov/cedarcreek
- For mass care we are working with 211 and ODHS to meet needs for impacted population.

Linn County

- Potential Public Safety Power Shutoffs could affect water treatment in the city of Sweet Home.
- The need for cooling centers may arise.
- EOC is open and monitoring in case emergency notification is needed.
 - o EOC Operation Hours 0900 to 2100 for Friday and Saturday. 24/7 call back plans in place in case an incident break overnight.
- Pacific Power has set up a community resource center in Sankey Park in Sweet Home.
- If power goes out for longer than 48 hours, emergency generators will likely be needed.

Jackson County

- Nothing significant to report.
- City of Medford: Secondary to Heat Advisory and Red Flag warnings, Medford has open a cooling shelter on Friday and Saturday from 12 noon 8 PM. In addition, Medford has closed Prescott Park to public access secondary to increased fire danger.

Josephine County

- Approximately 21,347 acres now burned in the Rum Creek Fire.
- No additional structures have been lost; structures lost remain at 8.
- Minor changes to evacuation levels since last report. As of yesterday (09/08/22), parts of the level 3 evacuation areas were reduced to level 2 to allow for repopulation; the changes were made in the Galice, Alemda County Park, and Indian Mary Park areas.
- County EOC partially deactivated. However, core functions and staff remain active to respond to any changes in the current situation.
- By 1400 today, animal and human sheltering will be concluded, demobilization, and resetting of sheltering site will occur following closing of the sheltering site.
- No further evacuation level downgrades will be reviewed or considered for 48 hours. This is due to continued Red Flag Warnings caused by a high heat index and low relative humidity over the next two days.

Klamath County

- The Van Meter fire is anticipated to turn it back on itself with the wind event and they expect to lift evacuation levels today.
- Two residences are reported destroyed, and about a dozen other agriculture structures. Some assessments are still ongoing but are confident there are no more residences destroyed.
- The local fair is going on in Klamath today, and generally feeling very positive about the outlook thanks to the shifting winds.
- No requests for support.

Lincoln County

No report received.

Marion County

- Marion County Emergency Management staff is monitoring, tracking, and documenting any Public Safety Power Shut-offs in Marion County PGE, Pacific Power and Consumers Power, Inc.
- Tracking Community Resource Centers, Mobile Response Units; updating the county website. Clearing up rumors.
- Currently, 892 customers are without power in the Silver Falls/Drakes Crossing area as well as Scotts Mills.
- All schools in the Silver Falls school district are closed.

Multnomah County

- Multnomah County experiencing preventive power shutoffs in two locations, with two additional locations going offline shortly.
- Response activity is to supply and staff resource centers for residents facing longterm power loss.
- No major fires are currently reported in Multnomah County and, while conditions are breezy, no reports of wind damage or other impacts yet.
- Multnomah County is operating resource centers in Eastern and Western portions of the counties, which
 will provide similar resources to the centers being operated by PGE in other regional locations. Visitors will
 be able to charge powered devices and get ice and water. Multnomah County Human Services is providing
 direct services to identified high-risk clients who live inside of the power shutoff areas.
- Resolving the impacts of the power shutoff lies in the timetable for PGE to inspect and re-energize lines.
- Portland UASI/ Regional Disaster Preparedness Organization
 - o Shared the Joint Information System meeting notes and situational awareness messages.
 - o OEM Region Coordinator Kate Trudeau in communication with UASI.

Tillamook County

• Nothing to report.

Union County

- Status normal.
- Sturgill Fire burning partly in Union County (most is in Wallowa County) is burning as expected with desired fire behavior for resource benefits.

Washington County

- Power lines across four PSPS zones within Washington County have been de-energized, affecting approximately 15,000 people
- We are coordinating with PGE on the alerting and implementation of PSPSs; second set of Everbridge alerts at issued at approximately 2030 hours last night.
- Preparing options for evacuation reception centers and shelters, if needed.
- Preparing for Everbridge warnings of wildfire evacuation areas.
- Supporting and coordinating public information activities at the county, county-wide, and regional level.
- Fire agencies are adding staff and equipment where possible.
- County EOC is stood up and operating in a limited virtual mode.

ESF #1 - Transportation

Oregon Department of Transportation

- ODOT has moved and staged ODOT resources in anticipation of additional evacuations.
- ODOT's AOC is monitoring the situation while ODOT Districts continue to assist with local planning efforts.
- Due to the conflagration for the for the Cedar Creek Fire that the August 30, 2022 waiver issued by ODOT Director Strickler now also applies to motor carriers and drivers providing direct assistance for emergency relief efforts related to this emergency.

ESF #2 - Communications

Oregon Department of Administrative Services

- Potential impacts to cellular, wireline, and radio communications due to loss of power (PSPS or weather).
 No current outages known. Impacts to communications may lead to the degrading of emergency alerting capabilities.
- Sourcing Radio Operators (RADOs) for the Double Creek Fire. Civil Air Patrol unable to fill. Seeking resources through Oregon 911 community. If unable to fill, may need to go to EMAC.
- Supporting OR-Alert messaging statewide for PSPS and fire evacuations.
- Completed Communications Infrastructure Analysis of Cedar Creek and Double Creek fires. Information passed on to local emergency managers/incident management teams.
- Will hold Communications Sector-wide Coordination Call at 1430 today.
- Concern for loss of cellular and wireline connectivity due to power loss. PSPS areas have been passed to all providers. ESF-2 has requested that carriers immediately report any outages.

Oregon Public Utility Commission

• Ongoing coordination of PIOs and unified public messaging.

ESF #3 - Public Works

Oregon Department of Transportation

ESF #4 - Firefighting

Oregon Office of the State Fire Marshal

- Green Incident Management Team (IMT) assigned to Double Creek & Sturgill Fires in Wallowa County along with 7 Oregon Fire Mutual Aid System (OFMAS) task forces and one Emergency Management Assistance Compact (EMAC) task force from Washington State. Conflagration Act invoked.
- 2 OFMAS strike teams assigned to Van Meter Fire in Klamath county through Immediate Response. Planned demob 9/10.
- 1 OFMAS task force staging in Linn County.
- 2 Washington State task forces pre-positioned: one each in Wasco & Lane counties.
- Red IMT assigned to staging in Salem. In-briefing 1500 today.
- Regional Mobilization Coordinators actively engaged with all current large fires in the state.
- Working closely with Pacific Northwest Coordinating Group to prioritize and staff large fires and plan for potential impacts of wind event.
- Hosted a Fire Defense Board Chief conference call today to discuss current situation and potential impacts
 of wind event.
 - o Encouraging local resources to staff up and plan for response within their areas of influence.
 - o Leaving OFMAS resources within their regions to the extent possible.
 - o Planning with current fires to address potential resource needs.
 - Planning with current fires to plan for sudden need to demob OFMAS resources to staff other incidents.

Oregon Department of Forestry

- ODF IMT 1- Hessel/Perkins and support modules assigned to Rum Creek. Deputy Agency Administrator
 Aaron Whitely assigned to support ODF Southwest Oregon District. Level 1-3 evacuations in place and
 monitoring for potential FEMA FMAG. Closing out today and tomorrow, back available at 0001 on Tuesday.
- ODF Incident Management Team 3- McCarty/Smith and support modules assigned to Van Meter. Agency
 Administrator Teresa Williams assigned to support ODF Southwest Oregon District. Level 1-3 evacuations in
 place
- Districts are canceling days off and are staffing additional engines through severity requests.
- Utilizing the ODF Multi Mission Aircraft with Infrared and night vision for detection.
- Extending type 3 helitack, seats and fire bosses.
- Moving severity resources to high priority areas.
- Coordinating with the Pacific Northwest Coordinating Group MAC.
- Districts are increasing public restrictions and Industrial Fire Precaution Levels as appropriate.
- Increase in social media fire prevention and awareness.
- Consider messaging to utility providers.
- Potential needs for public information officers, radio base operators, and traffic control points on Van Meter. Placed orders in Ops Center for radio base operators for Double Creek.
- Ordered additional radio base operators through NW Forest Fire Compact from British Columbia.
- Potential ordering single resource fire management overhead from North Carolina on State-to-State Agreement.

ESF #5 – Information and Planning

Oregon Department of Emergency Management

- Developed the ECC incident action plan for September 10 through September 11.
- Gathered situational awareness information from ESF partners and impacted jurisdictions to develop the 9/9 Situation Report.
- Developed an incident-specific story map to aid local jurisdictions and partners in maintaining situational awareness. PSPS information is also available in the <u>Oregon 2022 Wildfire Response Story Map</u>.
- Updated RAPTOR with Portland General Electric, Pacific Power, and EWEB PSPS Zones. Zone details is live in the default and fire configuration views.

ESF #6 - Mass Care

Oregon Department of Human Services

- ESF 6 is coordinating with counties through our Regional Emergency Coordinators to assess shelter/center support needs, to log county resources statewide with 211, and 211 has been activated to take calls.
- ESF 6 is ready to provide material and/or staff support to cooling and/or clean air centers as requested by the county.
- ESF 6 is working with ESF 8, Aging and People with Disabilities, Office of Developmental Disability Services, Child Welfare, Self-Sufficiency Program, and various community-based partners to ensure we have a databank of vulnerable persons should active outreach and assessment be required and/or to ensure rapid eligibility for Disaster SNAP benefits is available in areas with prolonged power shutoff.

American Red Cross

- Two Shelter Locations Overnight:
 - Josephine County Fairgrounds and Klamath County Fairgrounds supporting the Rum Creek and Van Meter Fires. Sheltering and wrapround services are being provided.
- We have deployed 2 additional Shelter Teams from our National Headquarters pool of Volunteers to support the region over the weekend and next week if additional needs arise. They will be staged in Medford and Portland until needed.

Oregon Parks and Recreation Department

• Public notification of services impacted (electricity, water, and/or sewage systems), halt on new reservations, and generators being used in critical areas.

ESF #7 – Resource Support

Oregon Department Administrative Services

• Actively monitoring Ops Center resource requests.

Oregon Department of Emergency Management

• Currently have 10 open requests and 12 closed requests in Ops Center.

ESF #8 - Health and Medical

Oregon Health Authority

• ESF8 has activated an IMT to plan and respond to 2022 Wildfires and PSPS. IMT meeting daily 9/9 to 9/13.

- As of this report, all requests (9) for Medicare and Medicaid data on individuals who rely on electrically
 powered medical devices to counties, in tandem with similar ODHS data. Those counties are: Clackamas,
 Douglas, Josephine, Linn, Marion, Multnomah, Polk, Washington, and Yamhill counties. No additional
 requests currently pending.
- Requests for these data should be submitted via OPsCtr.
- Oregon Emergency Department data monitoring, by Hospital Preparedness Program Region (HPP) and Urgent Care visits for prior 24hrs (9/08/2022):
- Increases in respiratory and asthma (non-COVID related) and behavioral health and anxiety as a chief complaint.
- ESF8 Operations is conducting a call with regional resource hospitals.
- Distributed an updated HAN alert with information on public health risks related to wildfires and PSPS and resources.

ESF #9 - Search and Rescue

Oregon Department of Emergency Management

ESF #10 - Hazardous Materials

Oregon Department of Environmental Quality

- DEQ monitoring OPS Center for hazardous materials incidents associated with this activation and any other requests. DEQ also maintains 24/7 Duty Officer coverage for hazardous materials incidents statewide. No hazardous materials incidents have been reported for this activation.
- DEQ monitoring Air Quality Conditions as part of ESF-8 responsibilities. There is no new update of the fore casted smoke conditions since yesterday's (9/8) which resulted in the following advisories:
 - DEQ and Lane Regional Air Protection Agency issued an air quality advisory Thursday for Coos,
 Curry, Deschutes, Douglas, Jackson, Josephine, Klamath, Lake, Lane, Umatilla, Union and Wallowa counties due to smoke from fires across Oregon and in central Idaho.
- DEQ expects the air quality advisory to last until at least Saturday. DEQ and partner agencies will continue to monitor smoke in the area.
- Additionally, winds from the east may bring smoke to many northwestern counties on Saturday, including Clackamas, Columbia, Hood River, Linn, Marion, Multnomah, Polk, Washington and Yamhill counties.

ESF #11 - Agriculture, Animals, and Natural Resources

Oregon Department of Agriculture

- No direct impacts at this time. Animal shelters are currently open in Klamath, Lane, and Marion Counties.
- We are currently monitoring the situation and remain available to provide assistance to counties for animal-related needs.
- Unknown number of animals currently in shelters.

ESF #12 - Energy

Oregon Department of Energy

- Continue monitoring the status of wildfires and high wind forecasts around the state to assess potential impacts to the liquid fuel supply and distribution system. This includes:
 - Working with the Oregon Department of Forestry and the Oregon Department of Aviation to assess jet fuel needs at the Roseburg, Lakeview, and La Grande airports supporting wildfire response.

- Working with fuel terminals and distributors to assess supply and distribution problems within proximity to fire activity and the Public Safety Power Shutoff zones around the state.
- There are no concerns to report at this time.

Oregon Public Utility Commission

- Public Safety Power Shutoffs (PSPSs) are in progress or planned imminent execution due to Wind Event (9/9/22 -9/8/22): PSPS is used as a last resort and must carefully balance the risk of possible fire ignition with the risks of disconnecting an essential service during a time of intense weather and high fire risk.
- Outages will likely occur as a result of wind damage in addition to the PSPS outages.
- Estimated restoration times are unknown at this time, but updates will be as they become available.

• Troubleshooting messaging issues with partners.

- Working with DAS on OR-Alert to resolve challenges with new registrations.
- Sponsored social media post re: evacuations in multiple languages.
- Directing people to resources for life safety information, including power outages and PSPS, and evacuations.
- Prioritizing equitable and accessible messaging.
