#### **8. Incident Summary:**

On September 8, 2022, the Oregon Office of Emergency Management (OEM) Emergency Coordination Center (ECC) activated to monitor wildfires and public safety power shutoffs, and facilitate information sharing and resource coordination. Evacuation orders are in place for six wildfires. Multiple state agencies and emergency management partners are supporting firefighting and response needs. Resources from two states are providing support through the Emergency Management Assistance Compact (EMAC).

Twenty-eight fires currently are burning in Oregon, with an estimated total of 241,983 acres burned.

Portland General Electric, Pacific Power, Lane Electric, and Eugene Water and Electric Board executed public safety power shutoffs (PSPS) for approximately 59,000 customers (electrical meters) within Benton, Clackamas, Douglas, Hood River, Lane, Lincoln, Linn, Marion, Polk, Multnomah, Tillamook, Washington and Yamhill Counties. PSPS were initiated September 9. As of 1400, 41,991 customers are without power due to PSPS preventive outages and other causes.

#### Clackamas County

#### Douglas County

- Coordinating with Pacific Power and Douglas Electrical Co-Op. Currently, Douglas Electric is not planning any PSPSs.
- Power was shut off yesterday to all identified PSPS areas in Douglas County at 1300 hrs.
- Full restoration of power was completed today at 1100 hrs.
- Community Resource Center (CRC) was demobilized at 1200 hrs.
- This will be the last situation report from Douglas County unless a situation or events warrant further coordination and/or response.

#### Hood River County

- Nothing to report.

Lane County

- Lightning started a significant wildfire event 15 miles east of Oakridge starting on 8/1/2022 around Cedar Creek.
- Strong east winds and low humidity are fueling the fires and moving them westward resulting in evacuations, possible structure loss, disrupted communications, and ongoing dangerous conditions. Winds are expected to decrease today and tomorrow.
- EOC is functional and active.
- Maintaining level 3 evacuation.
- Information from the field indicates 25% of residents remain in Oakridge and have chosen not to evacuate.
- Law enforcement has no requests.
- Forest Road 19 most likely has been compromised by this fire.
- EOP functioning on 24-hour operational period.
- A Temporary Evacuation Point (TEP) has been established at Lane Community College. The American Red Cross has opened a shelter for evacuees at the Lane County Fairgrounds Expo Hall. The shelter is serving 96 individuals and 60 small animals.
- ODOT has closed Highway 58 from Lowell to MP 70.
- Lane Electric will not be re-energizing power lines in West Fir and High Prairie at the request of Cedar Creek response command.
- All regional emergency coordinators are embedded in our EOC, and we appreciate everything you have given us at Lane County.

Linn County

- Power is off for about 6,000 Linn County residents. Most outages are in Sweet Home.
- Medical charging and oxygen refill requests are coming from the Sweet Home population.
- Community Resource Center is set up in City of Sweet Home at Sankey Park, staffed 0800 to 2200.
- Sankey Park Resource Center is setting up an oxygen refill station.
- Sweet Home Police Department has cooling and medical needs at its main station staffed 24/7.
- Ops Center requests have been submitted for ODHS support
- If power is shut off for Lebanon, we will need additional medical support.

Jackson County

Multnomah County

- Primary impact remains the four Public Safety Power Shutoff areas that have had power off since 9/9.
- Overnight, air quality degraded because of shifting wind patterns bringing in smoke from the Cedar Creek Fire. Levels have not yet reached orange level - unhealthy for sensitive populations.
- Multnomah County continues to assist with the operation of resource centers in the Portland West Hills and Corbett to provide charging, ice and water. Multnomah County Human Services also is providing

service to identified high-risk clients in these areas. PGE is expected to begin inspecting lines today. Resource centers will remain open until power is restored.

- Air quality is continuing to be monitored. Multnomah County issued a press release highlighting a ban on wood burning due to the air quality and providing preventive guidance for smoke impacts. For those living without access to clean air spaces, libraries are open, and masks are being distributed by outreach teams to unhoused populations.

#### Tillamook County

- No report received.

#### Union County

- Nothing new to report.

#### Washington County

- Power lines across four PSPS zones within Washington County have been de-energized, affecting approximately 15,000 people. In addition, power to the City of Banks also was turned off but has been restored.
- Two small fires broke out last night near Hagg Lake. A Level 2 evacuation notice was issued. Both fires were quickly suppressed. Evacuations have been lifted.
- We are coordinating with PGE on the alerting and implementation of PSPSs.
- Preparing options for evacuation reception centers and shelters, if needed.
- Preparing for Everbridge warnings of wildfire evacuation areas.
- Supporting and coordinating public information activities at the county, county-wide, and regional levels. PIOs are focusing on fire prevention messaging.
- Actively reaching out to the homeless and medical equipment dependent populations.
- Fire agencies are adding staff and equipment, where possible.
- County EOC is stood up and operating in a limited virtual mode.
- Supporting one charging station in Gaston. PGE has served approximately 100 people at its mobile response unit in Banks.

## 11. Activated Emergency Support Function (ESF) Reports

Information current as of 1400

### ESF #1 – Transportation

Oregon Department of Transportation

- Highway 58 is closed from mileposts 13-70 due to the Cedar Creek fire.
- Crews are staffing roadblocks and assisted with evacuations overnight.
- Due to the conflagration for the for the Cedar Creek Fire that the August 30, 2022, waiver issued by ODOT Director Strickler now also applies to motor carriers and drivers providing direct assistance for emergency relief efforts related to this emergency.

### ESF #2 – Communications

Oregon Department of Administrative Services

- AT&T reporting 4 towers out of service (OOS) (down from 9). Verizon reporting 3 towers OOS and 33 out of commercial power. 30 are on generator back up. T-Mobile reporting 8 sites OOS.
- Lane County reporting 3 towers potentially out of commercial power but all have back up batteries/generators that should last at least 7 days.
- Major communications site on Prospect Hill in Salem threatened.
- Lumen Willamina Central Office on generator power. Supports 911 services.
- Other carrier infrastructure including remote switches are also on generator or battery power.
- Coordinating with carriers to support their operations with local emergency managers.
- Communications Sector Coordination Call held yesterday. Two Strategic Technology Reserve Trailers deployed to support Double creek. 8 carrier deployables in place supporting fire operations.
- Fire evacuation messages still going out via OR-Alert. OR-Alert resources standing by to support.
- Unable to fill Radio Operators (RADO) request. Suggest escalating to EMAC.

Oregon Public Utility Commission

- Staying in communication with all partners. Maintaining communication with landline providers.
- Backup generators with many providers are keeping 911 active.
- Continue to work communication and priority efforts for restoration to communications back up as quickly as possible.

### ESF #3 – Public Works

Oregon Department of Transportation

- Nothing to report.

### ESF #4 – Firefighting

Oregon Office of the State Fire Marshal

- Multiple fires across Oregon continue to burn, including new starts yesterday and overnight, with current and potential impacts to communities and structures.

- Potential for east winds with current burn environment could impact large fires on the landscape and support rapid fire growth. In addition, new ignitions could see rapid rates of spread.
- Priority fire is the Cedar Creek incident and focus is for High Prairie, West Fir, and Oakridge. East side threatening Cultus Lake and south side is threatening Odell.
- Drawdown of available local fire resources continues to be evaluated as other incidents begin demobilization for possible re-allocation.
- Oregon Fire Mutual Aid System (OFMAS) is currently at Tier 3, severe drawdown of resources, EMAC assistance in place.
- Green IMT assigned to Double Creek & Sturgill Fires in Wallowa County- Conflagration Act invoked
  - \*Demob planned for 09/11 pending any unanticipated fire behavior.
  - \*2 OFMAS TFs & 1 EMAC Washington TF assigned
- Red IMT assigned to Cedar Creek Fire in Lane County (Unified Command with PNW Team 6)- Conflagration Act invoked
  - \*In-brief took place 09/10 @ 0800 in Oakridge
  - \*2 WA EMAC TFs, 1 OFMAS TF, and local TFs engaged. Currently evaluating and identifying additional resource needs.
- 2 OFMAS strike teams assigned to Van Meter Fire in Klamath County through Immediate Response. Planned demob 9/10, this afternoon.
- 2 OFMAS TFs mobilized to support the Mclver Fire near Estacada in addition to single resource overhead positions to supplement the local Type 3 team in place.
- OSFM mobilized air resources through our partners at ODF to support Salem Fire Department on the Vitae Springs incident; 1 Helo, 2 Single Engine Aerial Tankers (SEAT), and 1 air attack. Anticipate that the 2 SEATs will return to continue the firefight pending weather conditions. In addition, we are working to mobilize 1 OFMAS TF through Immediate Response to assist with firefighting efforts.
- Summary: 20 OFMAS task forces (including 3 WA EMAC) are actively engaged or pre-positioned and being coordinated by OSFM, in addition to the numerous local firefighting resources assigned to various fires.
- Agency Administrators and Regional Mobilization Coordinators continue to be actively engaged with all current emerging and large fires in the state.
- Working closely with Pacific Northwest Coordinating Group (PNWCG) to prioritize and staff large fires, plan for potential resource allocation needs, and ensure all suppression agencies in OR & WA have shared situational awareness.
- Continuing to evaluate and re-allocate OFMAS resources being demobilized from other fires to priority incidents across the state as OFMAS is experiencing a severe drawdown of resources. Continuing to encourage local resources to staff up and plan for responses within their jurisdictions.
- Planning continues with IMTs and local Fire Defense Board Chiefs (FDBC) to address potential resource needs on active incidents.

#### Oregon Department of Forestry

- ODF IMT 1 releasing from Rum Creek.
- ODF IMT 3 assigned to Van Meter.
- Unified Command on Milo Mclver Fire, 4 overhead assigned, 3 engines, 2 Coffee Creek AIC Crews, Dozer, Type 2 helicopter, and Fire Bosses.
- Vitae Springs Fire, supporting with 2 Fire Bosses and sending overhead.
- Districts are canceling days off and are staffing additional engines through severity requests.
- Utilizing the ODF Multi Mission Aircraft with Infrared and night vision for detection.
- Extending type 3 helitack, seats and fire bosses.
- Moving severity resources to high priority areas.

- Coordinating with the Pacific Northwest Coordinating Group MAC.
- Districts are increasing public restrictions and Industrial Fire Precaution Levels as appropriate.
- Increase in Social Media Fire Prevention and Awareness.
- Working with FEMA on multiple FMAG potential fires.

#### ESF #5 – Information and Planning

##### Oregon Department of Emergency Management

- Developed the ECC incident action plan for September 11 through September 12.
- Gathered situational awareness information from ESF partners and impacted jurisdictions to develop the September 10 situation report.
- Developed an incident-specific story map to aid local jurisdictions and partners in maintaining situational awareness. PSPS information is also available in the [Oregon 2022 Wildfire Response Story Map](#).
- Updated RAPTOR with Portland General Electric, Pacific Power, and EWEB PSPS Zones. Zone details is live in the default and fire configuration views.
- Developed a common operating picture including critical infrastructure information and resource request information.

#### ESF #6 – Mass Care

##### Oregon Department of Human Services

- ESF 6 is coordinating with counties through our Regional Emergency Coordinators to assess shelter/center support needs, to log county resources statewide with 211, and 211 has been activated to take calls.
- ESF 6 is ready to provide material and/or staff support to cooling and/or clean air centers as requested by the county. Counties are standing up evacuation shelters and requesting staff and resource support.
- ESF 6 is working with ESF 8, Aging and People with Disabilities, Office of Developmental Disability Services, Child Welfare, Self-Sufficiency Program, and various community-based partners to ensure we have a databank of vulnerable persons if active outreach and assessment is required and/or to ensure rapid eligibility for Disaster SNAP benefits is available in areas with prolonged power shutoff.
- ESF6 fulfilled Temporary Evacuation Point staffing needs to assist Lane County inform and process the Oakridge and West Fir Level 3 operations. Currently planning on supporting through Sunday.

##### American Red Cross

- We have had great coordination with our county partners last night and opened additional shelters throughout the night. Our current operations are the following:
  - Klamath County Fairgrounds – 3 overnight
  - The Expo Center Overnight – 96 overnight
  - Judson Middle School – 9 overnight
  - Clackamas Community College – 17 overnight
- We are working closely with our partners to provide feeding and wrap around services and coordinating with county and state partners to support AFN needs in our shelters.

##### Oregon Parks and Recreation Department

- Milo McIver
  - All patrons, volunteers and staff were evacuated from the park in approximately one-hour of the incident. The park and area are still under a level 3 evacuation.
  - The fire seems to have started by the power lines that run between the day use side of the park (Riverbend) then up to Springwater Road. The fire went up the hill, so the 5 restroom buildings,



- park roads, picnic shelters, disc golf course and other infrastructure on this side of the park are unharmed at this time.
  - The fire burned uphill toward Springwater Road near a couple or so residences. We are unsure if those residences were damaged.
  - The other end of the park with the equestrian lot, bat barn, campground, Riverside day use and the Clackamas Fish Hatchery sustained no damage.
  - Essentially the fire is burning but reducing fuel load currently.
  - All staff reported to Tryon Creek this morning for work and will do so until further notice.
- Dexter State Recreation Site
  - Currently being used to base heavy equipment for the Cedar Creek Fire.
  - The public is leaving the park and OPRD staff are controlling the gate.
- Lowell State Recreation Site
  - Will remain open tonight (9 SEP 22) for evacuees as it has power and water.

#### ESF #7 – Resource Support

Oregon Department Administrative Services

- Actively monitoring Ops Center resource requests.

Oregon Department of Emergency Management

- Currently have 17 open requests and 15 closed requests in Ops Center.

#### ESF #8 – Health and Medical

Oregon Health Authority

- ESF8 has activated an IMT to plan and respond to 2022 Wildfires and PSPS. IMT meeting daily 9/9 to 9/13.
- ESF8 Regional Emergency Coordinators are onsite in Lane and Linn counties per their Ops Center requests.
- As of this SITREP, ten requests (10) for Medicare and Medicaid data for individuals who rely on electrically powered medical devices to counties, in tandem with similar ODHS data.
  - Those counties are Lane, Clackamas, Douglas, Josephine, Linn, Marion, Multnomah, Polk, Washington, and Yamhill counties.
- No additional requests currently pending for these data.
- Requests for these data should be submitted via Ops Center.
- One ServOR request for Medical Reserve Corp volunteers being worked internally.
- Oregon emergency department and urgent care data monitoring, by Hospital Preparedness Program Region (HPP) visits for prior 24hrs (9/09/2022):

- Increases in respiratory and asthma (non-COVID related) and behavioral health and anxiety as a chief complaint.
- Visits mentioning power outage are increasing statewide.
- Poison center reporting carbon monoxide calls are above expected levels in region 7.
- Distributed an updated HAN alert with information on public health risks related to wildfires, PSPS, and resources.

**ESF #9 – Search and Rescue**

## Oregon Department of Emergency Management

- Monitoring situation in Lane County for possible FEMA USAR involvement if Cedar Creek fire moves into the suburban area.
- Contact with FEMA liaison officer for possible FEMA USAR deployment.

**ESF #10 – Hazardous Materials**

## Oregon Department of Environmental Quality

- DEQ is monitoring Ops Center for hazardous materials incidents associated with this activation and any other requests.
- DEQ maintains 24/7 Duty Officer coverage for hazardous materials incidents statewide. No hazardous materials incidents have been reported for this activation. No Ops Center requests for DEQ have been received.
- DEQ and others are monitoring Air Quality Conditions as part of their ESF-8 responsibilities.
- The Oregon Department of Environmental Quality extended its air quality advisory Saturday, Sept. 10, for Curry, Deschutes, Douglas, Jackson, Josephine, Klamath, Lake, eastern Lane, Umatilla, Union and Wallowa counties due to smoke from fires across Oregon and central Idaho. DEQ expanded the advisory to include Malheur County.
- DEQ expects the air quality advisory to last until at least Monday, Sept. 12. The advisory for Coos County ends today. DEQ and partner agencies will continue to monitor smoke in the area.

**ESF #11 – Agriculture, Animals, and Natural Resources**

## Oregon Department of Agriculture

- Lane County – companion animal shelter at Greenhill humane society (unknown census), livestock at fairgrounds (81 animals)
- Marion county – livestock shelter at state fairgrounds (19 animals)
- Clackamas County – shelter at Molalla Buckaroo Grounds (75 animals)
- We have been in communications with animal response leads in affected counties providing technical assistance as needed. No requests for resources have been received at this time.

**ESF #12 – Energy**

## Oregon Department of Energy

- Continue monitoring the status of wildfires and high wind forecasts around the state to assess potential impacts to the liquid fuel supply and distribution system. This includes:
  - Working with the Oregon Department of Forestry and the Oregon Department of Aviation to assess jet fuel needs at the Roseburg, Lakeview, and La Grande airports supporting wildfire response.
  - Working with fuel terminals and distributors to assess supply and distribution problems within proximity to fire activity and the Public Safety Power Shutoff zones around the state.
- There are no concerns to report currently.

**Oregon Public Utility Commission**

- CPI and Pacific Power are actively restoring customers.
- Portland General Electric will begin inspecting lines for restoration efforts to begin once the weather conditions safely allow.
- Restoration updates will be provided as they become available.
- EWEB and Lane Electric outages in Lane County are not only wind related but are also impacted by the Cedar Creek Fire. Restoration updates will be provided as this information becomes available.

##### **Oregon Department of Emergency Management**

- Closely monitoring, sharing and amplifying county, tribal, state and key partner messaging on wildfire, evacuations, shelter information for people and animals, smoke and air quality, heat, forecasts and power shutoffs – including best practices for medical devices, food and generator safety and respiratory and health concerns.
- Shared a pinned post on OEM’s Facebook page with several resources and links to key partner sites.
- Working closely with unified command in Lane County and OSFM for the Cedar Creek Fire to fact-check and clarify messaging. Coordinated with ODHS and 211 to ensure 211 is directing any Cedar Creek Fire and evacuation questions to the local Lane County non-emergency call center at 541-682-3977.
- Pushed out organic social graphics in the top four languages reminding people to please stay out of level 3 evacuation zones until officials announce it is safe.
- Working with GIS on language to address public concerns about RAPTOR fire activity map not loading (likely due to heavy traffic, PSPS or poor Internet).
- Directing media inquiries to appropriate agencies.
- OEM has a team of three PIOs working this event throughout the weekend to assist partners.

#### **ESF #16 – Volunteers and Donations**

##### **Oregon Department of Emergency Management**

- ESF16 is in contact with local COADs. Waiting on to hear further from local COAD if volunteer management support is needed.

#### **ESF #17 – Cyber and Critical Infrastructure Security**

##### **Oregon Department of Administrative Services**

- No report received.

##### **Oregon TITAN Fusion Center**

- Wildfire/wind events to include related Public Safety Power Shutoffs (PSPS) may have a direct impact on critical infrastructure and may result in cascading failures of critical systems.
- ESF 17 is analyzing data regarding potentially impacted infrastructure in high-risk areas. Data was accumulated and shared with planning for the communities of Oakridge/West Fir and Estacada.

#### **ESF #18 – Military Support**

##### **Oregon Military Department**

- 38 service members mobilized in support of Double Creek fire traffic assistance points.
- Two main bodies will arrive at fire camp this afternoon and begin integration.
- MEDEVAC repositioned from Medford to Redmond this morning.
