PROJECT SUMMARY

In Partnership with the Confluence Environmental Center, the Community Health Educator will mutually support Multnomah County's Lead Poisoning Prevention program (50%) and the remaining programs within the Healthy Homes and Families department (50%), through outreach to low-income communities and communities of color. Primary goals will be to increase lead screening clinic sites in these communities, recruit and train volunteers from the same and to engage communities in need with best practices information around a variety of health homes educational topics.

ESSENTIAL FUNCTIONS (to include, but not limited to):

- Recruit and coordinate outreach sites for community blood lead testing
- Recruit and coordinate the service of lead screening volunteers and on-call lead testers
- Conduct lead testing and provide community education at lead testing and education events
- Serve with Environmental Health staff to develop bilingual and low literacy educational and outreach materials for Healthy Homes topics (Green Cleaning, Lead, Radon, Pest Management, Mold, Indoor Air Quality)
- Develop Power Point presentations on Healthy Homes topics to present to youth in schools
- Respond to requests for community education on Healthy Homes topics to Head Starts and other community groups.
- Staff tables at Health Fairs and conduct outreach events on Healthy Homes topics.
- Maintain client confidentiality.
- May assist EPA Grant staff in developing educational materials and supporting documents for Indoor Air Quality for School Action Plans
- May assist Tobacco Prevention staff in distributing educational information to Spanish Speaking communities.
- Complete and submit all necessary Confluence/AmeriCorps paperwork and reports in a timely manner.
- Attend and complete all Confluence/AmeriCorps training and service requirements including orientation, training's, team meetings and national service days.
- Wear Confluence uniform and/or appropriate identifiers and required safety gear while performing service or attending
 official events.

POSITION REQUIREMENTS

- Experience with diverse ethnic populations, people of color, immigrants, seniors, youth, people with disabilities, or low-income individuals. OR
- Desire to serve with diverse groups of people to promote environmental stewardship and an ethic of service.
- Good Presentation skills
- Bi-lingual in Spanish/English
- Willingness to conduct Lead testing
- Communicate effectively to groups
- Must have a valid driver's license

- A cooperative manner and the ability to serve as part of a diverse team.
- 18 years of age or older, at beginning of service term.
- U.S. citizen, national or lawful permanent resident.
- Possession of a high school diploma or equivalent, or commit to earning one prior to receiving award.
- Ability to commit to the full term of service for which they are applying.
- Must successfully pass a fingerprint criminal history background check provided through the State of Oregon Clearinghouse, FBI criminal identification systems, the member's home state, and upon a satisfactory report from the National Sex Offender Registry.
- Regular and reliable attendance and dependability.
- AmeriCorps members can enroll in multiple terms of service that add up to the value of two full-time education awards.
 In other words, you can blend summer, part-time and full-time service positions and receive awards as long as the
 combined service terms don't exceed two full terms. You can also serve additional terms and elect not to receive an

- Community Outreach experience preferred

- Familiarity with low-income communities and/or communities of color.

- Upon successful completion of a term of service, eligible members receive an education award of \$5,550. The
 education award can be used to repay qualified student loans or for further education in an accredited institution of
 higher learning, vocational or trade schools. The education award is taxed in the year that it is used.
- Loan forbearance (after successful completion of a term of service, AmeriCorps will pay the accrued interest on qualified loans, which is taxable).
- Basic medical insurance (covers members only, not dependents; vision and dental not included).
- Child care allowance for those who qualify.
- Professional development, trainings and networking opportunities.
- Qualified individuals with disabilities and those from diverse backgrounds are strongly encouraged to apply. We provide reasonable accommodation for qualified individuals and conduct all activities in full accessible settings.
