Draft Policy Advisory Group Vision (from 7/13/10 discussion)

Assuming Oregon's first and subsequent Integrated Water Resources Strategies will be successful, the IWRS Policy Advisory Group has looked 50 years into the future and offers the following vision, describing the water resources of Oregon:

"Everywhere in our State, we see healthy waters, able to sustain a healthy economy, healthy environment, and healthy cultures and communities."

Healthy waters...are abundant and clean.

A healthy economy...is a diverse and balanced economy, nurturing and employing the State's natural resources and human capital to meet evolving local and global needs, including a desirable quality of life in rural and urban areas.

A healthy environment...includes fully functioning ecosystems, including headwaters, river systems, wetlands, forests, flood plains, estuaries, and aquifers.

Healthy cultures and communities...depend on adequate and reliable water supplies to sustain public health, safety, nourishment, recreation, sport, and other quality of life needs.
