Public Hearings This Week: May 18 – 22, 2015

The Water Resources Department will hold public hearings on proposed Division 93 rules governing grants and loans for water supply development projects to be funded under SB839 (2013). Hearings will be held this week in Pendleton (5-18), Ontario (5-19), Bend (5-20), Grants Pass (5-21), and Salem (5-22). An open house will take place prior to each hearing at the same location.
