1) Eastern Oregon U. library: has equipment connecting libraries throughout eastern Oregon. Participants could possibly go to their local library (per Federal Programs Coordinator, Library Development Services, Oregon State Library, 250 Winter St. NE, Salem, OR 97305, phone 503-378-5027, fax 503-378-6439, www.oregon.gov/OSL/LD)

2) Lincoln City: A couple of video conferencing options available. The court has extended access in the past to local attorneys who need video access for various things. As long as the need was associated with their duties as an attorney. (per Lincoln Co. 3) Baker, Haines, Halfway: Has videoconference units at public library branches in Baker, Haines, and Halfway. They are available for public use by reservation & at no charge. The units were provided by Libraries of Eastern Oregon (LEO), which got a grant to supply over a dozen units to libraries in rural areas.
