- The Oregon Child Forensic Interview Training (OCFIT) is a 3.5 day training focusing on conducting **Child Forensic Interviews in a Child Advocacy Center**. This type of interview may differ from first responder interviews in your region. You are responsible for understanding your MDT protocol regarding child interviewing in your region.
- The attached document is an **application, not an enrollment form**. Those who will conduct child forensic interviews in a Child Advocacy Center receive priority enrollment.
- Applications are reviewed and prioritized by Oregon Network of Child Advocacy Centers, Regional Service Providers, and the Oregon Department of Justice based on regional training needs, position, and agency representation.
- **You will be notified of your acceptance or waitlist status by March 30, 2020.**

This information is used to prioritize your application. **For purposes of this training, interview types are defined as follows:**

An initial responder interview is a minimal-facts interview conducted in the field by initial responders, such as law enforcement officers (LEs) and/or Department of Human Services Child Welfare Personnel (DHS-CWPs). These interviews elicit just enough information to establish safety and determine the need for a criminal investigation and/or an immediate medical evaluation. This interview typically takes place during the initial responder's first contact with the child/family and may be followed by an in-depth forensic interview.

A forensic interview is a developmentally sensitive and legally sound structured conversation with a child intended to elicit detailed information about a possible event(s) that the child may have experienced or witnessed. Forensic interviews are coordinated to avoid duplicative interviewing, follow research-based guidelines, and are conducted by trained professionals who participate in ongoing peer review, ideally in a child-friendly environment, such as a Child Advocacy Center (CAC).

--Completing a pre- and post-test, and daily quizzes that are built into each training module. The tests and quizzes will be based on the required reading materials and the curriculum. Earning a score of 85% or better on the post-test to receive a certificate of completion.

--I understand that I will receive a certificate of completion for completing this training. **This certificate does not indicate I am a certified Forensic Interviewer.** A Forensic Interviewer must be or have been a law enforcement officer or a DHS Child Welfare worker; or have a master's degree in a related field and two years of experience working with children; or a bachelor's degree and four years of experience working with children; and have completed the Oregon Child Forensic Interview Training.
