**Would you like to be entered into a drawing to win \$500?** All you need to do is complete your Health Assessment through the Moda Health website.

That's right! Moda Health and OEBB are giving away up to 18 \$500 gift cards to OEBB members who complete their online health assessment by May 31, 2014. If you've already completed this health assessment (on or after January 1, 2013), congratulations! You will be automatically entered into the drawing and may receive a \$500 pre-paid Visa gift card. If you haven't, here's how easy it is to enter:

Just go to the Moda Health website [www.modahealth.com/oebb](http://www.modahealth.com/oebb) and log in to your myModa account, or create an account if you don't have one yet. *To create an account you will need your Subscriber ID that is listed on your Moda Health medical card.* Once you're logged in, click on "Health Risk Assessment (HRA)" and then click the "Get Started" button.

**DO YOU HAVE A SPOUSE/PARTNER COVERED ON YOUR MEDICAL PLAN?**

If so, they can also enter the drawing by completing their own health assessment\*. They will need to log in separately using their individual myModa account. If they need to create a new myModa account, they should use the same subscriber ID number and create a separate username and password.

Keep in mind that the online health assessment will skip some questions based on previous answers and/or gender, so you won't see every question printed in the brochure, only those that pertain to you. And, please remember that the information you provide in the online health assessment is protected by law and will be kept confidential and secure. We take this issue very seriously and neither OEBB nor your employer will ever have access to your personal health information.

We hope you'll take advantage of this opportunity to learn about your health status, qualify for the \$500 drawing, and most of all embrace a healthy future.
