

Oregon Board of Psychologist Examiners Biennial Birth Month Renewal Process (OAR 858-010-0041)

Please note that license fees have increased. Why? License fees have not been increased for ten years! If we applied the Consumer Price Index over the last ten years, and increased fees each year accordingly, we would be at about the same fee.

Beginning January 1, 2010, license renewals for psychologists in Oregon will transition to a birth month cycle. The birth month renewal schedule will allow Board staff to process licenses quickly throughout the year. It will be easier to remember too!

This means a pro-rated two payment schedule based on a cost of \$31.25/month for your license. You will pay one partial payment in December 2009 good for a license through your birth month in 2010. **The second payment will provide you with a biennial license good through your birth month in 2012.**

Semi-Active ~ To qualify for Semi-Active status you must be: 1) 62 years old or better, and 2) Agree to practice no more than 20 hours/week.

The December payment schedule below is based on the new license fees rounded to the nearest dollar. Payment must be postmarked by December 31, 2009 to be timely.
