**In the Matter of:** The temporary suspension of OAR 858-020-0045 and OAR 858-020-0055(2).

**Need for the Temporary Rule(s):** The Board is conducting a comprehensive audit of license application files that were open during the past 3 years. This review is conducted at the direction of the Board and the results will be reviewed by the Board. The audit is being done to ensure that application files have been appropriately processed and that licenses have been issued to applicants who are qualified under all applicable statutory provisions and rules of the Board. The suspension of the rules identified above is necessary in order for the Board to expedite the review of licensing files where possible deficiencies have been identified, and to elicit a timely response from affected licensees. The Board intends that these temporary rule suspensions apply to the Board's investigative process immediately upon being filed with the Archives Division of the Secretary of State.

**Justification of Temporary Rule(s)** The Board finds that failure to promptly adopt these rule amendments through temporary rulemaking will prevent the Board from expeditiously asking licensees to respond to identified deficiencies in their license file.

This temporary rulemaking action will enhance the Board's ability to protect the public by expediting the Board's audit review process, to include contacting licensees to complete application files and to identify any person who may fail to qualify for licensure.
