1) Licensure

137 new applications have been received and 107 licenses have been issued in 2016. There are currently 181 active applications- including 74 practicing residents. There are 1,937 licensees: 1,565 active, 197 semi-active, 172 inactive, 2 suspended, and 1 on probation.

2) Consumer Protection

56 complaints have been filed in 2016. There are currently 30 open cases (including the investigation files scheduled for Board consideration): 21 licensees, 3 applicants, and 6 unlicensed practice cases. There are 2 contested cases, and 3 cases on appeal.
