41 new applications have been received and 30 licenses have been issued in 2019. There are currently 200 active applications- including 110 practicing

residents. There are 2,064 licensees: 1,618 active, 224 semi-active, 216 inactive, 3 suspended, and 3 on probation.

**b) Consumer Protection**

25 complaints have been filed in 2019. There are currently 69 open cases (including the investigation files scheduled for Board consideration): 49 licensees, 4 applicants, and 16 unlicensed practice cases. There are 7 contested cases and 2 cases on appeal.
