**a) Licensure**

14 new applications have been received and 16 licenses have been issued in 2020. There are currently 172 active applications- including 83 practicing residents. There are 2,132 licensees: 1,684 active, 219 semi-active, 223 inactive, 1 suspended, and 5 on probation.

**b) Consumer Protection**

12 complaints have been filed in 2020. There are currently 67 open cases (including the investigation files scheduled for Board consideration): 48 licensees, 4 applicants, and 15 unlicensed practice cases. There are 5 contested cases and 2 cases on appeal.
