RULE SUMMARY

The revisions to OAR 111-010-0015 include revised and new definitions for a new benefit offering, health savings accounts (HSAs) beginning October 1, 2011. The revisions include adding "Employee Assistance Program Plans" as defined under "Benefit plan" and also defining "Flexible benefit plan".

The Agency requests public comment on whether other options should be considered for achieving the rule's substantive goals while reducing negative economic impact of the rule on business.
