Amendments to 111-050-0010 align the definition of Eligible Early Retiree with OEBB's definition under Division 10 and clarify the language related continuation of coverage from active coverage to retiree coverage. Amendments to 111-00-0050 update language that aligns with the new eligibility verification and review language in OEBB's Division 80 Operations rule.
