Re: Oregon Geographic Information Council Fund Report

Dear Governor Kotek:

The Oregon Legislature approved House Bill 2906 (2017) establishing the Oregon Geographic Information Council (OGIC) Fund and requiring the State Chief Information Officer and the OGIC to submit to the Legislative Assembly and the Governor a report that summarizes the balance in the fund and deposits into and expenditures from the fund.

The OGIC Fund is primarily used to develop, acquire, and maintain geospatial framework data and activities related to sharing geospatial data among public bodies (ORS 276A.512.(3)(a)). Funds are mainly distributed through the Oregon Framework Data Development Program. The Geospatial Enterprise team within Enterprise Information Services provides support for OGIC and administers the Oregon Framework Data Development Program. The program begins with a request for proposals, followed by an extensive technical review process to select projects for grant awards. The grant program aligns with the state biennium and budget process. Detailed information about the program can be found on the following web page:

Several 2021-23 Framework Data Development Program grant projects were continued into the current biennium. The following four projects began in July 2024 and are scheduled to complete by the end of the 2025 calendar year:

- 1) update and maintenance to urban growth boundaries from 2004-2024,
- 2) update of the statewide zoning dataset,
- 3) creation of a data standard for statewide building footprints, and
- 4) completion of a statewide historic vegetation layer.
