SUBJECT: PARTNERSHIP POLICY

Any business, individual, educator, student, professional, or organization interested in supporting the revitalization efforts of Main Street Gardnerville shall be eligible for partnership as detailed below.

Main Street Gardnerville is a non-partisan organization that remains neutral on social, political, religious, and controversial issues. MSG reserves the right to decline to share any posts requested by business Partners that fall within these categories on their social media platforms.

Main Street Gardnerville does not discriminate against any individual or group based on race, color, religion, national origin, age, sex, disability, or any other protected status. Main Street Gardnerville has a zero-tolerance policy on discrimination and will not knowingly support or patronize any individual or group that discriminates.

mainstreetgardnerville.org Main Street Gardnerville is a 501c6 nonprofit corporation & an equal opportunity provider and employer. The business representative or individual who signs up to become a Main Street Gardnerville Partner is responsible for renewing the partnership.

Partnerships are non-refundable and non-transferable.

Partnerships are valid concurrent with the fiscal year, January 1st through December 31st. Renewals are due annually and subject to the current fees as established and amended from time to time by the Main Street Gardnerville Board of Directors. Partnerships shall have a 30-day grace period for renewal, after which the partnership expires, and the business or person(s) is removed from the active partnership role. Partnership renewals may be paid by cash, credit card, or check made to *"Main Street Gardnerville."*

Any increase in partnership dues is subject to review and determination by the Board of Directors, and all Partners will be duly notified if an annual increase for the following year is deemed applicable and appropriate.

Standard Business Partners are not guaranteed entry into Main Street Gardnerville functions or events that require admission or submission of an application to participate. Applications are taken in date and time order and are processed on a first-come, first-serve basis. Main Street Gardnerville fully supports free speech and freedom of creative expression but reserves the right to ban or remove any illegal, discriminatory, hateful, political, or offensive material in any advertisements, printed material, or online posts.

The Board of Directors, by an affirmative quorum vote of all the members of the Board, may suspend or terminate a Partner with or without cause at a meeting whose notice shall include such proposed suspension or termination. Written notice to the person subject to the vote shall be provided 14 days before the meeting to allow the Partner an opportunity to be heard.

Further, Main Street Gardnerville reserves the right to remove any listings or advertisements in either online form and/or printed form, cancel any event or function reservations, and withhold any Partner benefits or privileges for failure to pay dues or other outstanding invoices due to Main Street Gardnerville. These benefits or privileges can be reinstated by bringing dues current but do not guarantee reinstatement in a Main Street Gardnerville function.

Any Partner may resign by filing a written resignation with the Main Street Gardnerville office. Still, such resignation shall not relieve the Partner resigning of the obligation to pay any dues, assessments or other charges theretofore accrued and unpaid, and written notification must be received by Main Street Gardnerville at: 1407 US Highway 395 North, Gardnerville, NV 89410, along with any signage.
