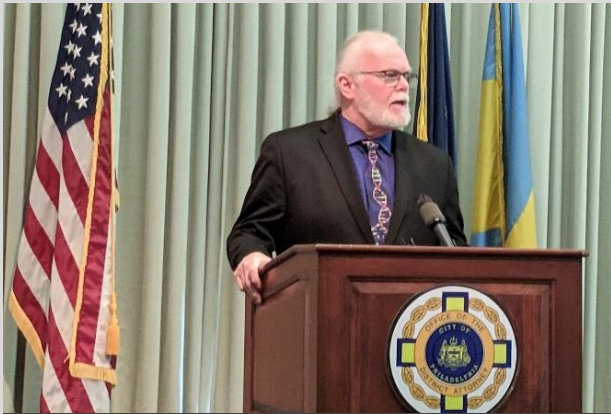

Listening to Innocence

Witness to Innocence (WTI) is an organization comprised of former inmates who were cleared of all charges and freed from death row. These exonerees seek to improve the criminal justice system by sharing their personal stories.

Accuracy & Justice is a project of WTI that brings together death row exonerees and criminal justice practitioners for facilitated conversations about the causes of wrongful convictions, as well as potential strategies for enhancing conviction integrity.

The workshops are facilitated by an attorney with specific expertise in wrongful capital convictions and feature a panel of three exonerated death row survivors who discuss their cases with law enforcement officers, prosecutors, judges, and other professionals.
