## WHO NEEDS TO REGISTER AS A FIRM WITH OSBAE?

Staff at the Oregon State Board of Architect Examiners (OSBAE) often discover that some businesses don't realize they must register with OSBAE and the Oregon Secretary of State's office. Oregon law allows an individual architect to practice under their own name only. If an individual, or group of individuals, wishes to provide architectural services under any other name, even if it is a derivative of the individual's name, that name must be registered with OSBAE as well as the Secretary of State.

Protecting the public health, safety, and welfare through the registration and regulation of the practice of architecture and provision of architectural services in Oregon

### **CONTINUING EDUCATION AUDIT**

The annual Continuing Education (CE) audit is underway. CE is a critical component of the Board's mission to protect the public health, safety, and welfare. The CE audit is conducted to determine if registrants are meeting the CE requirements listed in Oregon Administrative Rule (OAR) 806-010-0145. Each renewal cycle, eight percent of registered architects who submitted renewal applications are randomly selected for the CE audit. A letter was sent to selected registrants in early April with instructions regarding the audit requirements.

OSBAE would like to remind registrants that 24 hours of CE in architectural health, safety, and welfare (HSW) subjects is required to renew or reinstate an architect certificate of registration. Evidence of compliance must be maintained by the architect for a minimum of two years. Acceptable evidence of completion is a certificate or transcript that includes the name of the course provider, registrant's name, course title, completion date, and HSW hours received.

Please see OAR 806-010-0145 for the details regarding CE, as well as the flowchart that is available on our website. It's important to note that failing to comply with CE requirements, or making false statements or misrepresentations related to CE activities, may result in disciplinary action by the Board. Thank you for your diligence in maintaining your CE records.

## HELP SHAPE THE FUTURE OF ARCHITECTURE

NCARB is conducting an ambitious, once-in-adecade study, the Analysis of Practice, that will shape their programs and initiatives over the next several years. The previous version, the Practice Analysis, was conducted in 2012 and led to the evolution of the AXP and ARE 5.0. For the current Analysis of Practice to be as thorough and insightful as possible, NCARB needs to engage a diverse cross-section of people across the profession.

### What is the Analysis of Practice?

It is a profession-wide study that explores how architects are currently practicing and how that practice is likely to shift in the years ahead. The results will guide updates to NCARB's programs and services, including the national experience program and licensing exam, so that we can continue effectively protecting the public. OSBAE relies on these programs for candidates to meet the experience and examination requirements for registration.

## Why participate?

The profession is constantly evolving, and the path to licensure must evolve with it. To ensure these programs are aligned with modern architecture practice, NCARB regularly partners with researchers to conduct a comprehensive review of current practice. The previous study led to a restructuring of the Architectural Experience Program® (AXP®) and Architect Registration Examination® (ARE®).

## **INDIVIDUAL FEE UPDATES**

To ensure its finances for the coming years, the Oregon State Board of Architect Examiners (Board) approved a fee increase for individuals effective July 1, 2022.

At its February 18, 2022 meeting, the Board initiated rulemaking to amend OAR 806-010-0105 (Fee Schedule). This increase was part of the 2021-2023 biennial budget process. The proposed rulemaking was sent via email on March 9 to all registered architects and architectural firms.

A public hearing was held and written comments were accepted through March 23rd. Comments on the fee increases were received from 13 individuals with a majority in support of the proposal. The Board reviewed and discussed the comments at their April 15th meeting and voted to approve the fee increases.

## Why Fee Increases?

The Board is increasing fees to provide sufficient operating revenues for 2021-2023 and to help safeguard the continued financial solvency of the Board. The Board proposed the increases in consideration of anticipated expenditures for maintaining existing operations in the 2021-2023 budget. Individual registration fees were last increased in 1998 and renewal fees were last increased in 2002

Board revenues have not kept pace with operating expenses since 2013, but the Board chose to fund the deficits using its financial reserves. Rather than immediately raising fees when the imbalance in revenues and expenses emerged, the Board spent down its financial reserves. Expenses are predicted to outpace revenue for the next two biennia and the reserves are no longer a feasible source for covering deficits. The proposed increases are designed to rebalance the budget while still maintaining an adequate level of reserves to cover nine months of expenses.

As a semi-independent state agency, the Board is required to collect fees to cover its operating costs. No state General Fund dollars are available to the Board, which is why Board policy requires the maintenance of a limited financial reserves fund. With the number of new and renewing firms and individuals fluctuating year to year, the Board believes these increases bring the necessary stability to maintain the Board's mission of public health, safety, and welfare.


