CONTINUING EDUCATION AUDIT

The annual Continuing Education (CE) audit is underway. CE is a critical component of the Board's mission to protect the public health, safety, and welfare. The CE audit is conducted to determine if registrants are meeting the CE requirements listed in Oregon Administrative Rule (OAR) 806-010-0145. Each renewal cycle, eight percent of registered architects who submitted renewal applications are randomly selected for the CE audit. A letter was sent to selected registrants in late March with instructions regarding the audit requirements.

OSBAE would like to remind registrants that 24 hours of CE in architectural health, safety, and welfare (HSW) subjects is required to renew or reinstate an architect certificate of registration. Evidence of compliance must be maintained by the architect for a minimum of two years. Acceptable evidence of completion is a certificate or transcript that includes the name of the course provider, registrant's name, course title, completion date, and HSW hours received.

Please see OAR 806-010-0145 for the details regarding CE, as well as the flowchart that is available on our website. It's important to note that failing to comply with CE requirements, or making false statements or misrepresentations related to CE activities, may result in disciplinary action by the Board. Thank you for your diligence in maintaining your CE records.

NCARB UPDATES

ARE® Rolling Clock Rollback!

After careful review and consideration, NCARB's Board of Directors unanimously decided to retire the rolling clock policy, which placed a five-year expiration date on passed divisions of the Architect Registration Examination (ARE®). The rolling clock policy will be replaced with a new score validity policy, which bases the validity of passed ARE divisions on exam versions (such as ARE 4.0, ARE 5.0, etc.) rather than a set time frame. NCARB will reinstate previously expired divisions of ARE 4.0 for candidates who are seeking licensure in jurisdictions that do not have a rolling clock-type requirement, which includes Oregon. READY TO VOLUNTEER?

Consider the Oregon Safety Assessment Program!

The Oregon Safety Assessment Program (OrSAP) provides professional resources to local governments to help with the safety evaluation of buildings and infrastructure after a disaster. The goal of the safety assessment program is to perform these safety assessments as quickly as possible. Approved OrSAP personnel consist of professional engineers, **architects**, and certified building inspectors.

OrSAP is seeking architects to participate in this program as an evaluator. This role is essential in the first days after a destructive incident to evaluate the safety of potentially damaged structures. The skills you possess will be useful for the recovery of the community you are assisting.

Volunteers are a vital part of the OrSAP program. They are seeking qualified volunteers who want to be certified as a post-disaster safety evaluator, and have completed an approved OrSAP training course.

Once registration forms are received, credentials and training will be verified, and an OrSAP badge will be mailed to the address provided. An approved OrSAP refresher training must be taken every five years.
