

Form W-2 Frequently Asked Questions

1. Why was the Employer Name Changed on 2024 Form W-2?

- The State of Oregon employer name was changed to reflect the name of the program, Oregon Statewide Payroll Services or OSPS, at DAS who files the W-2 data on behalf of all state of Oregon workers. The group recently moved so the address had to be updated, and the TAX ID previously listed in the employer's name was not needed since that value is already listed in Form W-2, box b.

2. When will I receive my 2024 W-2?

- Form W-2 will be available online in Workday on January 17, 2025. For employees that elected to receive paper form W-2, those will be printed at the DAS Print Plant and mailed to employees' home mailing address listed in Workday as of Jan. 9, 2025. Hard copies will be mailed to employees no later than Jan. 31, 2025.

3. It's past January 31, 2025, and I did not receive my W-2 in the mail. How can I get a copy?

- You can access your electronic W-2 in Workday by following the steps below:
 - Click on the "Menu" at the top left
 - Click on the "Pay" app
 - Locate the "View" section and click on "My Tax Documents"

4. Did you elect to receive electronic copy of W-2?

- If you completed the election to receive electronic form W-2 you will be able to view and print your W-2 in Workday at anytime on or after January 17, 2025. This election will remain in place until you change the election.

- **Yes, access to form W-2 will be available in Workday by January 17, 2025.**
- Log in to Workday and follow the steps below to access your online W-2 copy:
 - Click on the "Menu" bottom at the top left
 - Click on the "Pay" app
 - Locate the "View" section and click on "My Tax Documents"
