Release Item 388: INT049 Review/Update Service Date Integration for BSD

Configuration updated to include future dated promotions in the system.
 Communication was sent out to HR and Payroll partners on Oct. 20, 2025.

Release Item 616: Update call back time calculation for American Federation of State, County & Municipal Employees (AFSCME) at Department of Corrections - Security Plus

 Call back time calculations were reviewed, approved and communicated to Department of Corrections (DOC). DOC will share this update with impacted staff.
