---



## Developed in partnership with:

- Governor's Office
- The Nine Tribes of Oregon
- Culturally-specific domestic violence and sexual assault (DVSA) providers
- Partner DVSA providers statewide.

**Tribes and culturally specific organizations know their communities best**

**Brought as a policy option package to the Oregon legislature in 2021 session**

**Received \$10M investment in the Legislatively Adopted Budget**

## **SIP Funding is intended to...**

---

- **Give Tribes and organizations autonomy in administration of their domestic violence and sexual assault programs**
- **Increase the accessibility and meaningful financial support to survivors**
- **Provide additional resources to Tribes and providers**



## Grant funding

**These grants will be awarded to cover:**

- Direct support services to survivors
- Two full-time equivalent staffing
- Administrative and other costs (travel, training, etc.)



# Allowable Uses of Funds

---

**The funds will be used to support staffing for DVSA Survivor services and to offer financial assistance to all vulnerable populations for resources including but not limited to:**

- Housing
- Legal fees
- Immigration fees
- Penalties
- Lock changes
- Cameras
- Rental assistance
- Moving costs
- Plane tickets
- License fees
- Housing applications
- Emergency hotels
- Etc.

# Allowable Uses of Funds

---

**Additionally, the funds will be used to support the following outcomes:**

1. Increased access to confidential advocacy services
2. Increased capacity to provide culturally responsive DVSA services
3. Access to Survivor Investment Dollars for survivors of DVSA throughout Oregon
4. Historically underserved populations that experience violence at a disproportionate rate will be positively impacted by the program
5. Services will help survivors to attain self-sufficiency and enhance safety from domestic violence
6. The program will focus on balancing well-being, minimizing trauma, and healing of children and youth.

## Timelines and Ongoing Funding

- Agreements and grants will be executed and funds will be disbursed prior to June 30, 2023.
- The funding for the 2023-25 biennium could be added through an amendment in July 2023. ODHS reserves the option to renew up to a cumulative maximum term of 6 years.
- Continued funding through 2023-25 is dependent on and to the extent approved by the Oregon Legislature.
