- 6 ODHS staff









- I am interested in knowing what everyone does and if there is a way to connect directly with them outside of these regularly scheduled times
- I am interested in providing feedback in a different way, so that I don't feel put on the spot
- I would like to see more community speaking up during the meeting
- Sometimes the meetings get repetitive. Time would be better spent addressing other upcoming issues or ongoing struggles.
- Can you add an introduction explaining the purpose of the meeting and the agenda items?
- I feel like the topics are client specific and don't directly apply to my work

## Based on the responses provided:

- The meeting time, length and duration works for most people
- ZoomGov is the preferred platform
- Camera use preference is divided but most would prefer to see the person who is speaking
- Most people attend to hear updates
- Attendees would like to see more collaboration and program presentations, from both community partners and ODHS
- Interested in Employment and Training presentations
- Interest in topics around housing

# Recommendations

---

1. Develop a purpose statement for the meeting (or revise current statement).
2. Expand the welcome to include Welcome, Purpose, Agenda, & recording acknowledgement.
3. Welcome camera usage and ask that all speakers turn on their camera (where possible).
4. Incorporate more program presentations.
5. Recruit community partner presentations, including other state agency programs.
6. Schedule presentations for each Employment and Training Program.
7. Incorporate housing topics.
8. Incorporate breakout sessions more frequently for community voice and connection.
9. Add additional meeting opportunities for collaboration.
10. Add Spanish interpretation to SSP Partner meetings.
11. Be intentional regarding repetition of material. Consider how much repetition is necessary.
12. Create an ongoing survey for community partner feedback. Provide the link in all Self-Sufficiency Partner Listserv communications.
13. Invite specific people, organizations and communities as suggested.
14. Follow-up with partners regarding feedback (where able).
15. Schedule requested presentations.
