

# SNAP Partner E-Meeting - August 2024



In lieu of an August meeting, Self-Sufficiency Programs offers the following updates and information to share.

## Summer EBT

As summer winds down, the deadline for families to apply for the new Summer EBT program is fast approaching. Please help share information about S-EBT with anyone who could benefit, as families may be unaware that they qualify.

The program offers \$120 per child to help cover grocery costs when school food programs are not as easy to access. The **application deadline** is Monday, **Sept. 2, 2024**. **To receive this essential food assistance**, it's crucial that **eligible families know how to apply**.



The Oregon Department of Human Services (ODHS) and the Oregon Department of Education (ODE) are urging families to **check their eligibility and apply before the deadline**. Once benefits are received, families have 122 days to use them.

## SNAP for students in college



As college students begin or return to classes they may qualify for SNAP if they meet specific conditions and eligibility requirements. [Partners for a Hunger-Free Oregon](#) has created a [SNAP College Toolkit](#) to guide colleges and community partners with providing SNAP outreach and application assistance. Students in higher education ages 50 and older do not have to meet the extra student-specific conditions.

## SNAP Replacement

Households that lose benefits due to emergencies, such as wildfires or power outages, have 10 days to request replacement of those benefits. Victims of electronic theft may request replacement within 30 days. Visit the [SNAP Replacement Benefits website](#) for additional details.
